It also included Council Tax Support Grant (757), which was not received in 18/19. These 4 items in 17/18 totalled 8,552. Also, a licence for grazing was received as one annual payment of 500 in 17/18, whereas it was allowed to be paid monthly in 18/19 so only 250 received during the year (a reduction of 250 compared to 17/18). However, these large reductions were partly offset because in 18/19 the PC received its first Community Infrastructure Levy money (2,071) and a donation towards the refurbishment of the War Memorial (4,000).
